Reservation Policy for SC, ST, and OBC for Admission in International School of Management Excellence.

# Introduction:

This policy document outlines the reservation guidelines for Scheduled Castes (SC), Scheduled Tribes (ST), and Other Backward Classes (OBC) for admission to International School of Management Excellence.

# **Objective:**

The primary objective of this reservation policy is to promote social inclusion, diversity, and equity in higher education by providing opportunities to historically marginalized and underrepresented communities.

# **Reservation Quotas:**

Scheduled Castes (SC), Scheduled Tribes (ST), Other Backward Classes (OBC): 6 % of the total admitted seats will be reserved for candidates belonging to SC, ST and OBC, in which 2% is reserved for SC, 1% for ST and 3% for candidates belonging to OBC.

# **Eligibility Criteria:**

- a. Candidates applying under SC/ST/OBC reservation must provide valid documentation certifying their caste/category status issued by competent authorities.
- b. Applicants must meet the minimum academic qualifications and eligibility criteria set by the institution for the respective courses/programs.
- c. Reservation benefits are applicable only to candidates who are citizens of India.

#### **Procedure for Admission:**

- a. Candidates applying under the reserved categories (SC/ST/OBC) will be required to indicate their category status in the application form.
- b. The admission process will adhere to the reservation quotas specified in this policy document.
- c. In case of vacancies in the reserved categories after the admission process, the seats may be filled through the general merit list.

# **Implementation and Compliance:**

- a. The Admission Committee will oversee the implementation of this reservation policy and ensure compliance with statutory regulations.
- Scholarships will be provided to the students belonging to SC, ST and OBC categories.
- c. Any disputes regarding caste/category certificates or reservation benefits will be resolved by the competent authority designated by the institution.

Reservation Policy for SC, ST, and OBC for Admission in International School of Management Excellence.

#### Introduction:

This policy document outlines the reservation guidelines for Scheduled Castes (SC). Scheduled Tribes (ST), and Other Backward Classes (OBC) for admission to International School of Management Excellence.

# **Objective:**

The primary objective of this reservation policy is to promote social inclusion, diversity, and equity in higher education by providing opportunities to historically marginalized and underrepresented communities.

## **Reservation Quotas:**

Scheduled Castes (SC), Scheduled Tribes (ST), Other Backward Classes (OBC): 6 % of the total Sanctioned seats will be reserved for candidates belonging to SC, ST and OBC, in which 2% is reserved for SC, 1% for ST and 3% for candidates belonging to OBC. In case the number of admitted seats are less than the sanctioned seats 6 % of the admitted seats belong to SC/ST/OBC.

# **Eligibility Criteria:**

- a. Candidates applying under SC/ST/OBC reservation must provide valid documentation certifying their caste/category status issued by competent authorities.
- b. Applicants must meet the minimum academic qualifications and eligibility criteria set by the institution for the respective courses/programs.
- c. Reservation benefits are applicable only to candidates who are citizens of India.

#### **Procedure for Admission:**

- a. Candidates applying under the reserved categories (SC/ST/OBC) will be required to indicate their category status in the application form.
- b. The admission process will adhere to the reservation quotas specified in this policy document.
- c. In case of vacancies in the reserved categories after the admission process, the seats may be filled through the general merit list.

# **Implementation and Compliance:**

- The Admission Committee will oversee the implementation of this reservation policy and ensure compliance with statutory regulations.
- b. Scholarships will be provided to the students belonging to SC, ST and OBC categories.
- c. Any disputes regarding caste/category certificates or reservation benefits will be resolved by the competent authority designated by the institution.
