

- 4. Candidates having same Score are listed in a chronological (ascending) order as per their date of
- 5. Candidates having same score have been given the same Merit, and the next Merit rank has been increased by the same number i.e. if there are two candidates at Merit2, Merit 3 would not be awarded to the next candidate but Merit 4 would be given.
